After 152 years in business, Waldo Bros. Company will close its operations versus relocate its Boston headquarters and warehouse outside of the Boston area. Our Boston location, 202 Southamptton Street, must be vacated by the end of December to make way for its new tenant. Currently, the Boston location, is scheduled to close on December 3, 2021, and it's South Windsor, CT branch office on December 10, 2021.

Our sales and operations staff are here to assist you and your team in identifying the actions necessary to support your material acquisition needs before our closure. When possible, we will assist with any transition to another supplier utilizing our manufacturers distributor network.
